It reaches nearly all government and commercial payers (approximately 2,100 connections), approximately 800,000 physicians, 117,000 dentists, 60,000 pharmacies, 5,500 hospitals, nearly 400 vendors, and 600 laboratories, which deliver significant value to our customers and other stakeholders. Our combined predecessor networks processed over 12 billion healthcare-related transactions in fiscal year 2016, covering over \$2 trillion in claims and touching one in five United States patient records.
2. Software and analytics: Our platform and products help enable our customers to achieve operational excellence, optimize payments and navigate the shift to value-based care. We provide software and analytics solutions for financial performance, payment accuracy, clinical decision management, value-based payment, provider and consumer engagement, and imaging and clinical workflow. We offer payment accuracy solutions for 9 of the top 10 payers in the United States; value-based payment solutions for 20 of the top 25 Medicare Advantage plans and all of the top 5 managed Medicaid plans; evidence-based clinical content to nearly 5,000 hospitals and facilities; and radiology and cardiology imaging solutions to 3,300 facilities globally.

Technology-enabled services: We provide expertise, resources and economies of scale to allow our customers to streamline operations, optimize clinical and financial performance and focus on patient care. Through our technology enabled services segment, we provide solutions for financial and administrative management, value-based care, communication and payment, pharmacy benefits administration and healthcare consulting.
